



## JOB DESCRIPTION

**TITLE:** Care Partner II  
**DEPARTMENT:** ICU (Intensive Care Unit)  
**REPORTS TO:** ICU Manager  
**FLSA:** Non-Exempt

### **SUMMARY OF JOB:**

Monitors patient rhythms. Provides unit secretarial services.

### **RESPONSIBILITIES:**

Colorado West Healthcare System expects job performance to be consistent with its mission and believes that each Employee contributes to improve performance by continuously searching for ways to increase efficiencies and enhance fiscal performance and viability.

### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

(The following statements are illustrative of the essential functions of the job and do not include other non-essential or marginal duties that may be required. Community Hospital reserves the right to modify or change the duties or essential functions of this job at any time. All responsibilities may not be performed by all incumbents.)

#### ***WHEN ASSIGNED AS TELETECH:***

1. Monitor and document patient rhythms.
2. Transcribing/entering orders.
3. Responsible for notifying patient care areas if there is a change in a patients rhythm
4. Orders supplies as needed.
5. Clean/disinfect Tele Packs when returned.
6. Coordinate with other departments' delivery of Tele Packs for use.
7. Assists with patient care when there are no Telemetry monitored patients.
8. Other duties as assigned by Registered Nurse and/or Director.

#### ***WHEN ASSIGNED TO WARD SECRETARY:***

1. Completes secretarial duties under the direction of professional nursing staff
  - a. Enters the physicians or L.I.P. orders in patient chart by utilizing Meditech order entry system, Medication Administration Records (MARs), and Meditech nursing module.
  - b. Prepares charts for admissions, discharges, and transfers.
  - c. Transcribes medications accurately onto the MAR
  - d. Obtains medical records as requested.
  - e. Schedules procedures under order of provider.
  - f. Assures valuables sheet is complete on each admission.
  - g. Maintains chart forms availability and breaks down charts after patients have been discharged.

**QUALIFICATIONS:**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

**EDUCATION and/or EXPERIENCE:**

High school diploma or equivalent with at least six (6) months of telemetry technical training and Ward Secretary training preferred.

**LANGUAGE SKILLS:**

Must be able to speak, read and write English. Ability to read and interpret documents such as medical charts, safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to effectively present information in one-on-one and small group situations to supervisors, patients, patient's family and other employees of organization. Able to work in a team-oriented environment.

**MATHEMATICAL SKILLS:**

Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent.

**REASONING ABILITY:**

Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

**INTERPERSONAL SKILLS:**

Demonstrates exceptional customer service skills using the "Whatever It Takes" philosophy; builds relationships and proactively respects others. Requires adaptability with regular interpersonal contact.

**DECISION MAKING ABILITY:**

Work limited by standards and procedures. Adapts to recurring operational situations using formal and informal channels. Unusual situations are reviewed with a manager.

**ANALYTICAL ABILITY:**

Apply basic business or technical principles to routine and moderately complex problems. Concentrates and pays close attention to detail.

**COMPUTER SKILLS:**

To perform this job successfully, an individual should be computer-literate and have working knowledge of Microsoft Office applications.

**PHYSICAL DEMANDS:**
